The American Academy of Pediatrics (AAP) Disaster Preparedness Advisory Council (DPAC) is pleased to provide you with information on its priority activities. # **ANTHRAX**

A final draft of the clinical report, titled "Pediatric Anthrax Clinical Guidance" was circulated for review by all AAP committees, councils, and sections as well as key federal agencies and external associations/organizations. The clinical report was edited and has been submitted for final AAP review and Centers for Disease Control and Prevention (CDC) clearance. The clinical report will be used to guide clinicians in management of anthrax in neonates, infants, children, adolescents, and young adults up to the age of 21 following a bioterror exposure. To optimally manage children during an anthrax bioterror event, the readily available and bidirectional flow of information between public health officials and pediatric health care providers, and clear recommendations and consistent messaging to the public from public health officials and health care providers will be extremely important.

#### PEDIATRIC BEREAVEMENT LECTURESHIP

Since the launch of the <u>Pediatric Bereavement Lectureship Program</u> in 2012, three lectureships have been conducted and were extremely successful:

- Boston University School of Medicine in Massachusetts March 7-8, 2013.
- Comer Children's Hospital at the University of Chicago in Illinois April 9-11, 2013.
- Riley Hospital for Children at Indiana University Health in Indiana April 22-24, 2013. This program's <u>Grand Rounds</u> presentation by David Schonfeld, MD, FAAP, expert speaker for the Pediatric Bereavement Lectureship Program, was archived online.

# CLINICAL GUIDANCE FOR USING SMALLPOX VACCINE IN A POST-EVENT VACCINATION PROGRAM

# COLLABORATIVE REGIONAL NETWORKS SURVEY PROJECT

The AAP has received funding to support implementation of a Collaborative Regional Networks Survey Project. #### 2013 HURRICANE SEASON

The National Oceanic and Atmospheric Association (NOAA) predicts an above-average hurricane season. This season is expected to produce 13-19 named storms, of which 6-9 are expected to become hurricanes and 3-5 to become major hurricanes. The AAP <u>Hurricanes</u>, <u>Tornadoes</u>, <u>and Storms</u> Web page includes the most up to date resources. The Federal Emergency Management Agency (FEMA) encourages citizens to assemble an <u>emergency kit</u> and develop a <u>family communications plan</u>.

## **NATIONAL PREPAREDNESS MONTH**

This September marks the tenth annual National Preparedness Month; the theme is "You can be the Hero". National Preparedness Month is sponsored by the FEMA Ready Campaign, and the AAP is a member of the National Preparedness Coalition. The goal of this effort is to enable citizens to prepare for and respond to all types of emergencies, including natural disasters and potential terrorist attacks. The AAP <a href="Children and Disasters">Children and Disasters</a> Web site has a dedicated Web page for National Preparedness Month. This Web page includes ideas for members who wish to get involved or implement preparedness activities, become more aware of strategies to address influenza prevention and control in high risk children, or utilize concepts and approaches included in the AAP <a href="Pediatric Preparedness Resource Kit">Pediatric Preparedness Resource Kit</a>.

Take one step to recognize National Preparedness Month!

- Educate peers on how to customize disaster planning to meet children's needs.
- Form an AAP Chapter committee.
- Develop relationships with state and local public health departments and emergency planners.
- Form a pediatric advisory committee with public health leaders.
- Link with existing preparedness efforts.
- Partner with a children's or community hospital to improve emergency and disaster readiness.
- Advocate for effective use of statewide vaccine registries.
- Connect with state volunteer agencies such as the <u>Medical Reserve Corps</u> or the <u>Emergency System for Advance Registration of Volunteer Health Professionals</u> (ESAR-VHP).
- Collaborate with child care programs or schools to help develop a coordinated disaster plan.
- Participate in local public health meetings.
- Get the seasonal influenza vaccine!

#### **INFLUENZA**

The AAP has updated its policy statement, "Recommendations for the Prevention and Treatment of Influenza in Children", and highlights important considerations in an AAP News article. Updates include:

- The influenza vaccine composition this season.
- Quadrivalent influenza vaccines are licensed and available.
- Multiple formulations of influenza vaccine are available this season.
- Annual universal influenza immunization is indicated for all children and adolescents 6 months of age and older.
- Egg-allergic children should be vaccinated.
- Antiviral medications continue to be important in the control of influenza.

The AAP receives support from the CDC in the form of a cooperative agreement to implement the "Public Health Program to Enhance the Health and Development of Infants and Children". The current AAP disaster preparedness initiatives focus on seasonal influenza prevention and control. Projects in progress include:

#### **KEY RESOURCES**

## Real Stories of Preparedness in Children and Youth with Special Health Care Needs

The CDC National Center on Birth Defects and Developmental Disabilities, CDC Office of Public Health Preparedness and Response, AAP, and Family Voices have partnered to recognize the unique experiences of families and health providers during emergency situations. This partnership has resulted in a collection of family stories that highlight emergency preparedness in children and youth with special health care needs. # National Report Card on Protecting Children During Disasters

For the sixth year in a row, Save the Children has commissioned a state-by-state assessment of US preparation and safety standards for children in child care facilities and in schools. The National Report Card on Protecting Children During Disasters grades all 50 states and the District of Columbia on four basic disaster preparedness and safety standards for children in child care and schools. To meet these critical benchmarks, states must require all regulated child care settings to have written plans for evacuation and relocation, for family reunification following an emergency, as well as a specific plan to assist children with disabilities and those children with access and functional needs.

# **Guide for Developing High-Quality School Emergency Operations Plans**

In June 2013, the Obama Administration released the Guide for Developing High-Quality School Emergency Operations Plans. The guides incorporate lessons learned from the shootings in Newtown and Oak Creek as well as the tornadoes in Oklahoma.

#### **Progress Report on Executive Actions to Help Reduce Gun Violence**

A progress report was released by the Obama Administration that showed completion or progress on executive actions to help reduce gun violence. Progress on strengthening the existing background check system, empowering law enforcement, making schools safer, encouraging responsible gun ownership, ending the freeze on gun violence research, preserving the rights of health providers to protect their patients and communities, and improving access to mental health care was reported.

# School Safety Planning: Why Fortification Is Not the Answer

Following the 2012 Sandy Hook shooting, 183 organizations and more than 200 experts in school safety, researchers and practitioners, came together to create a <u>position statement</u> on how best to address school violence. This article examines why intensifying security in schools should be reconsidered. An article featured in *AAP News* "Sandy Hook Pediatricians Share Grief, Advice, Hope 6 Months after Tragedy", tells the stories of pediatricians who lived in the area of the shooting at Sandy Hook school. The article also references what the AAP Connecticut Chapter has accomplished since the shooting.

#### Mortality From a Tornado Outbreak, Alabama, April 27, 2011

This report studies the deaths from the tornado outbreak in Alabama on April 27, 2011, and identifies measures to prevent future tornado-related fatalities. Methods for collecting information, results of the study, and conclusions are discussed. The study concludes that providing community shelters for those without safe rooms or basements, promoting peer warnings, and encouraging a comprehensive personal or family preparedness plan are of utmost importance to preventing tornado-related deaths in future events.

# Nationwide Response Issues After an Improvised Nuclear Device Attack: Medical and Public Health Considerations for Neighboring Jurisdictions - Workshop Summary

On January 23-24, 2013, in partnership with the National Association of County & City Health Officials (NACCHO), the Institute of Medicine Forum on Medical and Public Health Preparedness for Catastrophic Events hosted a workshop that focused on key response requirements faced by local and regional public health and health care systems in response to an Improvised Nuclear Device detonation. This document summarizes the workshop.

# A Multi—Systems Approach to Pediatric Trauma

This is a free virtual online course for all healthcare providers that discusses a multi-systems approach to pediatric trauma. Each module presents a different facet of the multi-systems approach and how they interface and interact together to medically treat the pediatric trauma patient.

## States Align to Make it Easier for Doctors to Communicate After Disasters

An article from American Medical News, published in July 2013, describes how a secure, HIPAA-compliant email system (Direct), allowed for physicians, hospitals, and other health professionals in one state to send emails with attachments to hospitals and health professionals in any of the other states participating in the program. This allows for physicians to access critical patient health information, when those fleeing a disaster area can't see their regular physician or go to their usual hospital.

# Crisis Standards of Care: A Toolkit for Indicators and Triggers

This report examines indicators and triggers that guide the implementation of crisis standards of care and provides a discussion toolkit to help stakeholders establish indicators and triggers for their own communities. Although not pediatric specific, the crisis standards of care recommendations can be used for any population. A crisis standard of care is a guideline that is developed before a disaster strikes to help health care providers decide how to provide the best possible medical care when there are not enough resources to give all patients the level of care they would receive under normal circumstances.

# AAP HealthyChildren.org Web Site Provides Text-to-Speech Technology

HealthyChildren.org has added text-to-speech technology to all of its article pages, making the site more accessible to those with visual impairments, reading difficulties, or learning disabilities, as well as those whose native language is different from that of the Web site.

# Office of Emergency Care Research

The Office of Emergency Care Research (OECR) elected Jeremy Brown, MD, to be the first permanent director. The OECR is housed in the National Institutes of Health (NIH) National Institute of General Medical Sciences. This office focuses on basic, clinical and translational emergency care research and training across NIH. It coordinates, catalyzes and communicates about NIH funding opportunities in emergency care research and fosters the training of future researchers in this field.

#### **OPPORTUNITIES**

The DPAC has developed a 3-year AAP Strategic Plan for Disaster Preparedness, with one of the goals being "increase pediatric resident exposure and knowledge about disaster preparedness and response". The AAP is currently looking for information on resident education tools for disaster preparedness.
